There was a good voter turnout in Holt County for the Presidential Preference Primary Election on Tuesday, March 15, 2016. According to the unofficial election results, 1,317 people cast their votes, which is 40.01% of the registered voters in the county.

Dr. Roy Wilson, Doctor of Veterinary Medicine (DVM), is closing his office in Mound City. He is citing the pursuit of personal and professional endeavors as the reason for making the difficult decision to close Rafter Cross Veterinary Services. The clinic served the animal needs in Holt County and the surrounding areas for eight years, starting at his farm outside of Craig, MO, in the spring of 2007, before moving into Craig. In 2011, the office was moved to Mound City and continued to grow.

"I have had some great patients and clients during this time," stated Dr. Wilson. "I am thankful for the chance to serve in Holt County. Since childhood, it was my dream to be a mixed animal veterinarian in a farming community."

The Rafter Cross Veterinary Clinic will be open Monday, March 21, and Wednesday, March 23, for clients to pick up a copy of their animal's medical records.



Missouri State Highway Patrol provides safety tips for severe weather

Spring's varying temperatures and weather patterns are expected to bring thunderstorms the next several months. Thunderstorms can include heavy rains, thunder, lightning, tornadoes, straightline winds, flash floods and hail. They can form quickly, and ALL thunderstorms are dangerous. A typical thunderstorm is 15 miles in diameter and lasts an average of 30 minutes. When they occur, seek shelter, and pay attention to weather reports and instructions. Secure loose objects If you're going to be on the

pass can create a dangerous wind tunnel effect. If you are driving, you should stop and take shelter in a nearby building. If you are driving in a rural area, drive away from the tornado to the closest building. If you cannot get away, seek shelter in a roadside ditch. Protect yourself from flying debris by covering your head with your arms, a coat, or a blanket. Be prepared to move quickly in case the ditch fills with water.

No matter what the forecast: water, you need a safe boating plan. During severe weather, stay off the water. Currents become swift and dangerous. Fixed objects and fast moving water are a bad combination: Don't go boating in these conditions. Floating debris can easily capsize or sink a boat. After heavy rains, lakes have more debris to watch for. Boaters should always keep an eve on the weather. When visibility decreases, boaters need to slow down. No matter what the season: Watch for changes in the weather. When you hear the thunder in the distance, respond to it. Don't wait until you see the lightning. Get to shore ... Get to safety. When dangerous weather approaches, whether you are on land or on the water, implement your safety plan, postpone activities, monitor the weather and get to a safe place.

An interior room without windows on the lowest floor is the safest shelter location. Do not seek shelter in a cafeteria, gymnasium, or other large open room because the roof might collapse. Road work in Holt County

Road work is being done by the Northwest District of the Missouri Department of Transportation (MoDOT) in Holt County. A resurfacing project is underway on Route 118 between U.S. Route 59 in Mound City and Route 111 near Big Lake, MO. Contractors from Chester Bross Construction Company are working with MoDOT to prepare the road for resurfacing. Crews are working on the shoulders of the project through Friday, March 18.

On Monday, March 21, contractors will begin pavement repairs on the portion of Route 118 between U.S. Route 59 in Mound City and approximately one mile west of U.S. Route 59. The pavement repair work will continue through Friday, March 25, 2016.

These first portions of the

This is for Missouri farmer and household pesticides only. All pesticides will be accepted including herbicides, insecticides, fungicides, rodenticides and de-wormers. In addition, empty triple-rinsed plastic pesticide containers up to 30 gallons in size will be accepted. Other items such as paint, electronics, fluorescent bulbs and explosives will NOT be accepted. Pesticides and containers from businesses

From 2012 to 2015, the Missouri Pesticide Collection Program conducted 26 events, collecting more than 193,700 pounds of waste pesticide. All materials collected are managed as pesticide and herbicide waste, are field characterized, sampled (if necessary), segregated and placed into proper Department of Transportation shipping containers with approved labels and markings. The waste is transported and managed at an approved licensed disposal facility where the waste is disposed of in a manner that is environmentally friendly.





St. Patrick's Day was made an official Christian feast day in the early 17th Century and is observed by the Catholic Church, the Anglican Communion, the Eastern Orthodox Church, and Lutheran Church. The day commemorates Saint Patrick and the arrival of Christianity in Ireland, and celebrates the heritage and culture of the Irish in general. Celebrations generally involve public parades and festivals, and the wearing of green attire or shamrocks. Christians also attend church services and the Lenten restrictions on eating and drinking alcohol are lifted for the

> St. Patrick's Day is a public holiday in the Republic of Ireland, Northern Ireland, the Canadian province of Newfoundland and Labrador, and the British Overseas Territory of Montserrat. It is also widely celebrated by the Irish around the world, especially in Great Britain, Cana-Australia, and New Zealand.

Saint Patrick was a 5th Century Romano-British Christian missionary and bishop in Ireland. Much of what is known about Saint Patrick comes from the Declaration, which was allegedly written by Patrick himself. It is believed that he was born in Roman Britain in the fourth century, into a wealthy Romano-British family. His father was a deacon and his grandfather was a priest in the Christian church. the age of 16, he was kidnapped

by Irish raiders and taken as a that he spent six years there working as a shepherd and that during this time he "found God". The Declaration says that God told Patrick to flee to the coast, where a ship would be waiting to take him home. After making his way home, Patrick went on to become a priest.

According to tradition, Patrick returned to Ireland to convert the pagan Irish to Christianity. The

many years evangelizing in the northern half of Ireland and converted "thousands". Patrick's efforts to convert, subjugate, and drive off the Pagans (specifically the Celts) were eventually turned into an allegory in which he drove "snakes" out of Ireland. (Ireland never had any snakes.)

Tradition holds that he died on March 17 and was buried da, the United States, Argentina, at Downpatrick. Over the following centuries, many legends grew up around Patrick and he became Ireland's foremost saint.

On St. Patrick's Day, it is customary to wear shamrocks and/ or green clothing or accessories (the "wearing of the green"). Saint Patrick is said to have used the shamrock, a three-leaved plant, to explain the Holy Trinity to the pagan Irish. This story first appears in writing in 1726, though it may be older.

The color green has been asso-According to the Declaration, at ciated with Ireland since at least the 1640s, when the green harp flag was used by the Irish Cathoslave to Gaelic Ireland. It says lic Confederation. Green ribbons and shamrocks have been worn on St. Patrick's Day since at least City Feed.

The phrase "wearing of the green" comes from a song of the same name, which laments United Irishmen supporters being persecuted for wearing green. Throughout the 19th and 20th centuries, the color green and its association with St. Patrick's Day grew.

St. Patrick's Day, while not a legal holiday in the United States, is nonetheless widely recognized and observed throughout the country as a celebration of Irish and Irish American culture. Celebrations include prominent displays of the color green, eating and drinking, religious observances, and numerous parades. The holiday has been celebrated on the North American continent since the late 18th Century.




