Rivers and creeks swelling from deluge of rain; more could be on the way

Northwest Missouri has received more than its share of rainfall the past two months. Farmers have raced between storms to plant the fields, only to have the heavy rains wash away the seed. Other fields have been put into prevented planting. Prevented planting provisions in crop insurance policies provide coverage when extreme weather conditions prevent expected plantings; however, many farmers will have to take a loss on any chemicals or fertilizer applied to the field.

A torrential storm with several tornadoes crossed Holt County on Thursday, June 11, leaving streams and rivers surging to the top and breaching their levees. Squaw Creek covered the roadways of Highway 59 and I-29 between Mound City and

Craig, MO, on Thursday evening, closing both highways for several hours. A small creek topped its bank and covered Route N, four miles north of Mound City. That portion of Route N remained closed until the next day, Friday, June 12. Squaw Creek levee broke on the west side of the creek late Thursday night, dumping water into the fields north of Bigelow, MO. There were no reports of damage from tornadoes.

Heavy rains in Atchison County, MO, continue to be a threat to the Tarkio River, Little Tarkio River and other smaller streams that travel through Holt County. Residents near these waterways are keeping a close eye on future storms traveling through the area.

Hunger Heroes step up to make a difference

When the Mound City R-2 middle school Language Arts teacher, Mrs. Hamm, gave her students a summer assignment, she didn't realize that two young ladies would take the assignment and run so far with it. Jessie Horseman and KyRyein Panning will be seventh graders this fall. Mrs. Hamm's assignment has become their summer project. The assignment was to pick a community involvement project, research the topic and present a proposal slide show at the end of the school year.

Jessie and KyRyein researched their topic, "Poverty and Hunger." Initially, the two wanted to take their study worldwide or nationwide. Jessie's mother, Cheryl Horseman, sat down with the girls and discussed the fact that there is poverty and hunger "right here in Holt County." The girls talked to Tara Chaney, the coordinator of Community Services in Holt County, and determined that their project would be best served here at home.

Jessie and KyRyein teamed up with Holt County's Community Services, where the food donated will be distributed in the community to help alleviate hunger within Holt County. The girls set a goal of collecting 1,000 pounds of non-perishable food to be given to Community Services. They set up a food drive in front of Mound City Thriftway on Monday, May 25, and collected 246 pounds of food. After an anonymous donor left over 200 pounds of food on Jessie's porch, along with other donations, the duo

presented 706 pounds of food to Ms. Chaney at Community Services.

On Saturday, June 13, the Hunger Heroes were in front of Price Grocery in Oregon, MO, during the Oregon Trail Day where they collected another 175 pounds of food items.

The Hunger Heroes will be at the Rumble By The Refuge at the rodeo grounds in Mound City on Friday and Saturday, June 26-27, accepting non-perishable food items at the gate. On Sunday, June 28, the duo will set up in the Forest City park during the town's Independence Day celebration.

Mound City's 4th of July celebration will find the Hunger Heroes back in front of Mound City Thriftway on Friday, July

3, and participating in the parade on Saturday, July 4. There will be a drop off box by the stage at Griffith Park in Mound City during the celebration on Saturday.

Boxes for donations are available daily at the Dollar General Store and Mound City Thriftway in Mound City, and Price Grocery in Oregon.

On Monday, July 6, Jessie and KyRyein will pick up the last of the donations and make their final trip to Community Services with the food. After the project is completed the two girls will create a power point presentation for Mrs. Hamm's class this fall.

Storm blows through area and causes two accidents

High winds on Thursday, June 11, caused the trailer of a 2015 International Tractor semi truck to overturn at mile marker 95.2 of southbound I-29 in Holt County.

At 6:10 p.m., Charles F. Brooks, 52, of Ashley, IL, was southbound on I-29, three miles north of Craig, MO, when high winds caused the trailer of the semi to overturn on the roadway. The vehicle traveled off the east side of I-29 and the tractor overturned. The tractor and trailer, which received extensive damage, came to rest on the driver's side in the median of I-29.

Brooks was alone in the truck, and was transported by Atchison/Holt Ambulance to Mosaic Life Care in St. Joseph, MO, with moderate injuries. The tractor/trailer was towed from the scene by Benefiel Towing of Hamburg,

IA.

The accident was investigated by Missouri State Highway Patrol Sergeant M.P. Quilty, assisted by Trooper J.W. Cotter, Mound City Police Department, Holt County Sheriff's Department, Craig Fire Department and Mound City Rural Fire District.

The Missouri Department of Transportation (MoDOT) reported that another semi tractor-trailer jack-knifed at the northbound 70 mile marker on I-29 at 7:21 p.m. The Holt County Sheriff's Department assisted with traffic control. According to the Farm Service Agency of the United States Department of Agriculture (USDA) office in Mound City, rainfall in Mound City for the month of May was recorded at 7.74 inches. In the first eleven days of June, Mound City has received 4.79 inches of rain, with 1.57 of that amount registered on Thursday, June 11.

Flash flooding in the area on Thursday, June 11, caused the closing of several roads in the area. The northbound and southbound lanes of Interstate 29 (I-29) were closed at 11:30 p.m. due to Squaw Creek getting over the roadway. Northbound traffic was diverted at

mile marker 56 (Highway 71) and southbound traffic was diverted at mile marker 110 (Highway 136). I-29 reopened to traffic at 12:45 a.m.

U.S. Route 59 north of Mound City between Route N and Jamboree Road also closed on Thursday night at 10:15 p.m. due to Squaw Creek over the roadway. The highway was opened back up to traffic at 2 a.m.

Route N between Route C and Juniper Drive closed to traffic at 9:45 p.m. on Thursday. It remained closed until Friday afternoon, June 12.

50 Years Ago - 1965

- The Rev. Douglas A. Robbins, pastor of St. Peter's Lutheran Church, Craig, and St. John's Lutheran Church, Corning, had accepted a call to serve a church in Texas. Pastor Holstein of Concordia Lutheran Church, Mound City, would serve the two congregations during the vacancy.

- The Missouri House of Representatives' Appropriations' Committee had approved an amendment to the Omnibus Bill which allowed for \$110,000 for the proposed dredging of Big Lake in Holt County; and \$25,000 for the fund to settle the Missouri-Nebraska border dispute.

- Holt County delegates to Missouri Boys' State were Denny Kurtz, David Richards and Tom Mendenhall, all of Oregon, and Stanley Wright of Corning. Jesse Clement of Skidmore would also be attending.

- The Maitland Bluegrass Festival would be held for four days in late June. A full schedule of activities was in place, including carnival rides provided by the Sonny Meyer Rides.

25 Years Ago - 1990

- Campground work at Big Lake State Park had many people upset because of the timing of renovations that had closed the campground during one of the busiest periods, including two major holidays - Memorial Day and July 4th. The work was expected to have been completed by Memorial Day, but work did not begin until May 1 due to a paperwork snafu in Jefferson City.

- Sue Horvath, head librarian in Mound City for four and one-half years, submitted her resignation to the library board. She had accepted a full-time position with River Bluffs Public Library System in St. Joseph.

- Mound City Chamber of Commerce members helped Sandy Young celebrate the grand opening of Mood Swings, a new hair care shop on West 6th Street in downtown Mound City.

- The Mound City Development Corporation elected new officers. Mason McIntire was elected president; Dr. J.B. McRae, vice-president; Sonny McCormack, secretary; and Lucyle Benne, treasurer.

10 Years Ago - 2005

- Mound City was getting a new license bureau fee agent and it likely would be car dealer Joe Laukemper instead of Mayor David Duncan.

- Mound City aldermen agreed to sell a big diamond ring for at least \$15,000 after hearing that new appraisals showed it was worth up to \$28,000. The city had recently obtained a court order allowing it to sell the ring confiscated by police here better than five years prior.

- The eighth annual Buckin' Blast Rodeo was a two-day event scheduled for the end of the month. The Shotts Post 121 American Legion would again sponsor the event with Greg and Kathi Clement being the rodeo co-producers.

- A Craig Reunion would be held this year after a group of 13 showed up at a planning meeting in May. The annual celebration - counting the current year - had continued for 110 years.

- A better look at plans to renovate the first floor of the Mound City City Hall was needed before the city would spend as much as \$100,000.

What do you remember?

The Holt County Historical Society is looking for answers to these questions that have been submitted by researchers.



LINCOLN COUNTRY SCHOOL

A photo of the students in 1924-25; Mary Meyer was the teacher. Lincoln was a country school located north of Oregon. Robert Callow was the teacher in 1895-96. In another *Mound City News* clipping, there were 53 enrolled there in 1885 and C.C. Moore was the teacher.

At the society's Genealogy and Research Center in Mound City the country school history files provide endless information for researchers. There is a file for every Holt County country school, many with photos and all with news clippings or documents. In 1895-96 a report published in the *Holt County Sentinel* lists 75 country schools in Holt County along with schools in Oregon, Mound City, Maitland, Craig, Forest City, Bigelow and Corning. The society has several original school ledgers, filled with student names from Benton, Brush College, Burr Oak, Center, Cottonwood, Culp, Franklin, Haigler/Hinkle, Mann, Mineral Springs, Pleasant Hill, Summit, Walker and Wood country schools. Any school records are always welcomed to add to the shelves for research.

Holt County Commission orders special election date; rat infestation reported in New Point, MO; new election equipment purchased

The Holt County Commission met Monday, May 18, 2015, at 9:00 a.m. at the Holt County Courthouse in Oregon, MO, with Presiding Commissioner Mark Sitherwood, First District Commissioner Bill Gordon and Second District Commissioner David Carroll in attendance.

Mike Long, of Mike Long Construction, appeared before the commission to discuss the ongoing contract for placement of 911 signs throughout the county.

At 10:00 a.m. commissioners open sealed bids for work on a Federal Emergency Management Agency (FEMA) project package as follows: Bid #1: Hufford Dirt Works, Mound City, \$29,335; Bid #2: Hall Construction, Mound City, \$41,539; and Bid #3: Mike Long Construction, Mound City, \$14,550. After due consideration, Commissioner Carroll made a motion to accept the low bid from Mike Long Construction. Commissioner Gordon seconded the motion. Approved.

Commissioners cancelled the planned pre-construction hearing scheduled for Tuesday, May 19, 2015, at 10:00 a.m. with plans to reschedule it in the near future.

Commissioners then took up an order calling for a Special Election, Tuesday, August 4, 2015, for a question to reinstate a one-half cent sales tax for the General Revenue Fund with a 10-year sunset. The current 10-year one-half cent

sales tax expires on Tuesday, June 30, 2015. This sales tax is tied to a property tax rollback, which requires the county to roll back property tax by 50% of the sales tax revenue each year. Commissioner Gordon made a motion to call for the election. Commissioner Carroll seconded the motion. Approved.

Greg Razer with Senator Claire McCaskill's office approached the commission to discuss various issues of legislation, regulation and local government impacts.

Being no further business, the commission adjourned until Tuesday, May 26, 2015.

The Holt County Commission met Tuesday, May 26, 2015, at 9:00 a.m. with Presiding Commissioner Mark Sitherwood, First District Commissioner Bill Gordon and Second District Commissioner David Carroll in attendance.

County Clerk Kathy J. Holstine presented minutes for approval. Following discussion, Commissioner Gordon made a motion to approve the minutes as presented. Commissioner Carroll seconded the motion. Approved.

Carla Markt, Oregon, approached the commission to provide a report on a recent Missouri River Recovery and Implementation (MRRIC) meeting she attended in Sioux Falls, SD. Mrs. Markt represented local government interests on the MRRIC board and is sponsored by Holt County in that position. She noted that several river

management alternatives were discussed at the meeting including two that called for six-week spring or fall rises in the river that would negatively impact farming, drainage and levee infrastructure in this area of the Missouri River.

Brenda Nelson, R.N., Health Department Administrator, joined the commission to present a Women, Infant and Children (WIC) contract renewal and to discuss an issue with catering services from an unlicensed operator. She also reported the Health Department has been contacted about a problem in New Point with a rat infestation. She has contacted the State Department of Public Health for guidance in the matter since there are several citizens who have reported concern for public health safety.

Mike Long of Mike Long Construction, Mound City, approached the commission to report on 911 sign installation under a contract with the county which is set to expire at the end of June. He requested a 60-day extension due to weather to complete the existing project. Commissioner Carroll made a motion to approve an extension to August 1, 2015. Commissioner Gordon seconded the motion. Approved.

Sheriff Scott Wedlock met with the commission to discuss recent storms.

Road and Bridge Supervisor Daryl Biermann joined the commis-

sion to review upcoming FEMA work scheduled in the northern part of the county. He also discussed a shift by Road and Bridge employee, Bill Keiffer, from full-time at the Oregon barn to part-time at the Mound City barn.

Larry Tempel, auditor, McBride and Lock, presented an exit briefing with the commission for the county's two-year fiscal audit covering 2013 and 2014. He reported no significant findings in financial compliance, but will recommend the county adopt an investment policy to comply with state statute. Commissioners agreed to review sample policies and draft one for county compliance.

Being no further business, the commission adjourned until Monday, June 1, 2015.

The Holt County Commission met Monday, June 1, 2015, at 9:00 a.m. with Presiding Commissioner Mark Sitherwood, First District Commissioner Bill Gordon and Second District Commissioner David Carroll in attendance.

Commissioners took up for review and approval a Finding of Fact from a public hearing held April 27, 2015, to create an Enhanced Enterprise Zone (EEZ). Following discussion, Commissioner Carroll made a motion to approve the Finding of Fact and further recommended that an ordinance be drafted and adopted by the public entities encompassed within the EEZ. Commissioner

Gordon seconded the motion. Approved.

Wayne Flanary, Agronomist, University of Missouri Extension, joined the commission to discuss wet field conditions and the impacts on planting, weed maintenance regimes and yield impacts.

County Clerk Kathy J. Holstine approached the commission in her capacity as Election Authority of Holt County and presented two pricing quotes for new election equipment from the two vendors approved to sell election equipment in the state of Missouri. Ms. Holstine reported she has conducted demonstrations on both types of equipment with a sampling of bi-partisan election judges and her staff. The two quotes are as follows: Elkin-Swyers Company, Springfield, MO: \$48,500 and \$4,678 annual maintenance; Henry M. Adkins, Clinton, MO: \$52,951 and \$5,650 annual maintenance. After discussion and review of feedback from the election judges and county clerk staff, Commissioner Gordon made a motion to approve the quote and purchase equipment from Henry M. Adkins. Commissioner Carroll seconded the motion. Approved.

Brenda Nelson, R.N., Health Department Administrator, met with the commission to report on matters of her department, including the return of vaccines which were being safely stored in another county due to a scheduled power

outage in Oregon. The power outage would have rendered the vaccines unusable because of an unsafe temperature in the freezer.

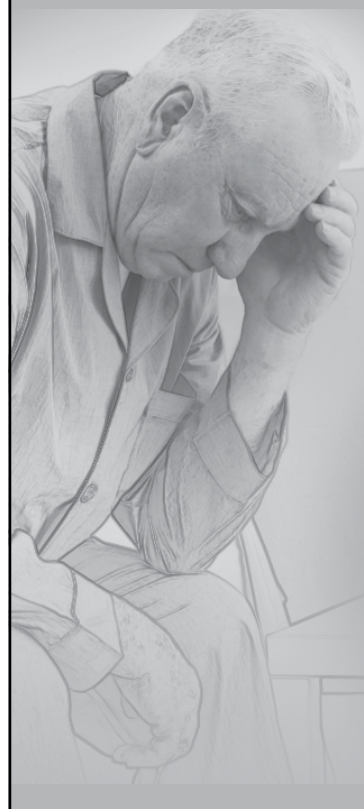

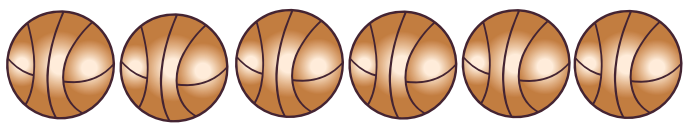

KCP&L prepared for hot weather and offers customers tips

KCP&L wants customers to be prepared for extreme temperatures this summer.

With the first day of summer quickly approaching, KCP&L wants to make sure customers are prepared for extreme temperatures that may impact the region. The utility wants to remind those in need that bill payment options are available and a few simple tips can help them beat the heat this summer.

As temperatures rise, so do electric bills. KCP&L wants to urge customers who are behind

on their bills and have not yet established payment arrangements to contact customer service to learn about payment programs that may be available to them. "Energy usage often goes up during the summer because of the cost to cool homes, and it can be easy to fall behind on these higher electric bills," said Elizabeth Danforth, Director of Public Affairs at KCP&L. "It's important that we help our cus-

tomers find payment solutions for their particular situation and keep them safe during times of extreme heat."

In addition, KCP&L wants to remind customers that the Hot Weather Rule took effect on June 1 and runs through Sept. 30. Under this rule, residential disconnects are prohibited when the temperature is forecast to be above 95 degrees or the heat index above 105 degrees between 6 a.m. to 9 p.m. in the next 24-hour period. However, customers will still be charged for en-

ergy used during any suspended disconnection periods.

Customer safety tips

Not only does energy usage go up when it gets hot, but so do safety incidents. KCP&L wants to make sure everyone stays safe during extreme temperatures. "The safety of our customers and employees is always our number one priority," said Danforth. "We want to educate our customers on a few ways that they can stay cool and safe during times of extreme heat."

Below are several easy steps

customers can take to stay cool and ensure their safety during a heat wave:

- Seek a cool public place, such as a library or mall if you don't have air conditioning or fans. Call United Way 2-1-1 for assistance or more information about public cooling centers in Missouri or Kansas.
- Help control a home's temperature by closing shades, blinds, drapes and curtains.
- Use ceiling and portable fans to circulate air.

• Keep the air conditioner clean and free from debris. Make sure the filter is clean and change it when necessary.

• Drink plenty of water and avoid strenuous activity.

• Wear loose fitting, lightweight, natural fiber clothing.

MDC managed deer hunt applications open July 1

Beginning July 1, deer hunters can apply online for a shot at more than 5,100 slots for nearly 100 Missouri Department of Conservation (MDC) managed deer hunts. The managed hunts will take place from mid-September through mid-January at conservation areas, state parks, national wildlife refuges, urban parks and other public areas. The online application period runs July 1-31.

To apply, visit the MDC website at mdc.mo.gov/node/11252 between July 1 and 31. MDC will post drawing results at the same website address from Sept. 1 through Jan. 15. Applicants who get drawn will receive area maps and other hunt information by mail.

The hunts are open to Missouri residents and non-residents and help achieve MDC's

deer-management goals for the state while providing additional hunting opportunities. Types of hunts include archery, crossbow, muzzleloader, historic methods, and modern firearms, plus youth hunts and hunts for people with disabilities.

Seventeen managed hunts will be held exclusively for hunters with disabilities. Eligibility varies by hunt so applicants should call the area hosting the hunt for details and to apply. Wheelchair-confined hunters may apply for more than one managed hunt offered at select conservation areas with a written request due by July 31 to: Missouri Department of Conservation, Attn: Managed Deer Hunts, PO Box 180, Jefferson City, MO 65102-0180.

All other hunters may apply

for only one managed hunt per year. Hunters may apply individually or as groups of up to six, except for youth-only hunts. Youths age 11-15 years by the date of the desired hunt who are hunter-education certified may apply individually or with one other youth for youth hunts and must be accompanied on the hunt by a qualified adult mentor.

All applicants will need their nine-digit Conservation ID number to complete the application process. Conservation ID numbers are listed on hunting and fishing permits and Missouri Conservation Heritage Cards.

Resident or non-resident managed deer hunting permits are required to participate in managed hunts. These permits will be available to success-

ful applicants beginning Sept. 1 from permit vendors, online through MDC's e-Permits at mdc.mo.gov/node/10901, or through MDC's free hunting mobile app -- MO Hunting.

Hunter education is required for firearms managed hunts, unless the hunter is exempt by age or other reason. Hunter education classes fill up quickly as fall hunting seasons approach. For more information on hunter education options and classes, visit mdc.mo.gov/node/3095.

MDC uses a weighted-preference-point system to give previously unsuccessful applicants an advantage in future drawings. Hunters who apply for the first time or who were drawn for hunts the previous year are statistically less likely to be drawn than those who

entered but were not drawn in previous years.

Details about managed hunts can be found in MDC's "2015 Fall Deer & Turkey Hunting Regulations and Informa-

tion" booklet available in July at MDC offices and nature centers, from permit vendors around the state, and online at mdc.mo.gov.

Opportunities available in youth summer jobs' program

There are opportunities available in two summer employment programs offered through the Missouri Career Center in Maryville, MO. Youth must be between the ages of 16-24 and meet income qualifications to participate. Participants will be able to work 240 hours and will be paid \$8 per hour.

The Maryville Career Center also has a position available through the State Park Youth Corps program (SPYC) to work at Big Lake State Park in Big Lake, MO. Youth must be between the ages of 17-24 and meet income guidelines to participate in the SPYC. Participants will be able to work 300 hours and will be paid \$8 per hour. 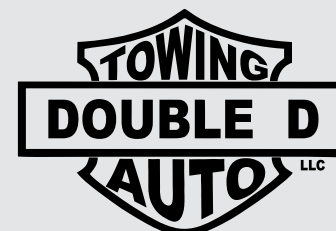
