The 6th Annual Great Northwest Wine Fest opened the gates at 12 noon and the guests came pouring in for "A Day and Evening of Life Enhancement." At the registration table, each guest that was over 21 years old and wished to taste the huge variety of wines was given a complimentary wine glass and wristband.

Community Food Pantry celebrates one year of service; shelves empty each month

The Community Food Pantry in Mound City is open every second and fourth Friday of each month from 2-6 p.m., to provide food assistance to qualifying residents. Coordinated by community area churches, the pantry's mission statement is: "Through the love of Christ, the Community Food Pantry exists to help those in need of food assistance in the northern half of Holt County, MO, with special emphasis on reaching low-income individuals

and families." (Hope House in Forest City, MO, services the South Holt R-1 school district.)

Approximately 80 families utilize the services of the Community Food Pantry, emptying the shelves as quickly as the workers fill them up. Several local churches and individuals donate non-perishable food items, delivered to the pantry

Car thieves nabbed in Mound City

On Tuesday, September 15, a citizen reported to Holt County dispatch that two males were spray painting a vehicle in the parking lot of Dollar General, located at 426 State Street, in Mound City, MO. The Mound City Police Department was dispatched to the location.

Upon arrival at the scene, the license plate on the vehicle was called into dispatch, which revealed that the vehicle was stolen from St. Joseph, MO. One male began walking from the vehicle toward the front of the Dollar General store and then fled on foot. The Mound City Police chased after the suspect. The suspect ran north of the Dollar General location and through an alley. Officers caught up to the suspect in the alley north of Sixth Street. The suspect continued fleeing and entered a residence.

A young man was alone in the residence. The suspect ran into the kitchen where the boy was fixing an after school snack. The officer entered the residence, the suspect was taken into custody inside the resi-

dence and transported back to the scene.

A Holt County Sheriff's deputy arrived at the scene at Dollar General shortly after the foot pursuit started and observed a male subject at the front of the vehicle and took him into custody. While walking to the deputy's cruiser, the suspect attempted to flee, was subdued and placed in the cruiser.

The two perpetrators are identified as Dylan Hart and Christopher Hart, both of St. Joseph, MO. Dylan Hart is being held in jail on charges of Tampering with a Motor Vehicle and Burglary; bond was set at \$100,000. Christopher Hart is being held in jail on charges of Tampering with a Motor Vehicle and Resisting Arrest; bond was set at \$125,000.

The Mound City Police Department and Holt County Sheriff's Department state that the quick response to the situation was due to a private citizen's call to 911 to report suspicious activity.

Remembering

Do you remember back when we were kids or maybe what your parents or grandparents told you about the basic way we harvested grain, especially corn? After all we were part of the "corn belt", marketing most of it through livestock, yes? That was when all the work was done with what was called "hands on labor".

Since Dad always had hired help, especially during harvest season, I never shucked corn by hand or worked teams in the fields much, other than to help hand pick enough corn rows so that I could get on the tractor and pull the picker and wagon. That was my job.

Things kept improving each year. Remember the first picker/sheller that picked the corn, shelled it and put it up in the hopper to be hauled from the field like today? They had a demo and I attended it. At the beginning it left so much shelled grain on the ground that someone suggested that the refuge wouldn't have to feed the geese and deer, they could just eat down the row. We hunters decided that following it would be the place to hunt. Now the modern combines have taken the place of the many steps we had to go through to accomplish the same thing. They are still being improved, larger in size and even larger price tags.

When we moved to Louisiana the first time we thought all the crops growing along the highway with all of the pink and white buds and blossoms had to be some kind of berry bushes. We soon found out they were young cotton plants in bloom. Having grown up on the farm

where we were used to seeing persons doing fieldwork and teams of horses, mules and tractors either preparing the soil for planting or harvesting it, we were not prepared for the amount of work a cotton farmer (plantation owner) went through. Even in the early 60's, most of the cultivating, insect treatment and picking of the cotton itself was done by hand - by the plantation families. It was something to see them out chopping cotton, as they called it. It was really weed control and maybe trimming the vine itself. Better than seeing the work was hearing them singing. It seeming like everyone had a good voice. I don't think I could do much singing while pulling a sack on one shoulder and picking the ripe cotton from the vine. There's a good song out, "I never chopped cotton, but my mother did, and my sister did." Mine didn't, but women did more than their share.

They sprayed the field with a plane, to do what was called defoliation. It was done so they could get to the cotton easier, helping also to save hands. I tried picking cotton once and ended up with sore fingers. The mature cotton plants were picked and then went through a cotton gin to clean and remove the seeds. The cotton was then graded and put in bales to be auctioned off to various manufacturing companies.

Our family, Betty, the boys and I, were "Yankees", and for a while there weren't many. We were privileged to be able to learn more about southern farming and living.

When the civil rights law was enforced

in the mid 60s, most of the cotton fields were like up here, rented out, but were called sharecroppers rather than renters. During the civil rights movement when most of the sharecroppers were persuaded to leave the area and protest by not coming back at harvest time, the fields of ripe cotton were left in the fields. This was organized to penalize the plantation owners. Even though most of the older workers stayed, there weren't enough to harvest the good crop. This was a break for the dealers, who had mechanized pickers, mostly one row. One plantation owner told me that since I came from where we had all kinds of power equipment that surely I could help him get a new picker to work. We did.

At that time one row pickers were all there was and the only thing one of these had in common with our equipment here was the principal of gathering something and putting it in a hopper to be hauled off. Instead of the picker rollers, these had a series of moving metal pieces, like fingers that actually could pluck the ripe cotton off the vine to enable it to be taken up to a big basket-like hopper. Getting them adjusted to only pluck the ripe cotton was the trick. Back in the 40's here, getting the snapping rollers adjusted to keep from shelling or putting more of the corn field up in the wagon was hard, but nothing like that cotton picker. I sure know what the saying "that durned cotton picker" means. With all this climate change, hey, we may be growing cotton up here! If you have trouble with the picker, just call me.

This Week's History

From the *Mound City News* archives

50 Years Ago - 1965

... as published in a series of articles on the function and philosophy of the Citizens' Advisory Committee under the Workable Program for the City of Mound City: *Recorded figures tell the declining story of Mound City and Holt County. According to these figures Holt County is losing one and one-fourth persons each day. In 1950 there were 9,260 people in the county. Today there are approximately 6,402. In Holt County, 57 businesses have closed their doors since 1950. There are 98 less school children than a year ago. Projecting this trend into the future, by 1980 there will be less than 3,600 people in Holt County with a parallel decline in businesses. Can we be so disinterested and so complacent as to ignore these figures? Can we turn our backs on these facts and without a struggle let Mound City and Holt County dwindle and decay into nothingness? There are things that we can do to preserve this land we love. That is the purpose of the Workable Program. But it takes willing and dedicated people to work the Workable Program.*

- The greatest destruction ever wrought by vandals was accomplished at the Mound City Golf Association Clubhouse this week. This was the third time within about a year that such had occurred and members were very discouraged about the expensive results.

25 Years Ago - 1990

- It's a quiet little place now, but there was a time when Fortescue was known as the "Queen of the Tark" and was "quite a lively town," said May Dodson, 92, a resident whose family had deep roots there. The little town along Tarkio Creek was founded 100 years ago, and to commemorate its anniversary, the Holt County Historical Society had planned an "Old-Fashioned Afternoon" at the museum in Fortescue.

- Heather Flanary and Bill Russell were crowned queen and king of homecoming activities at Nodaway-Holt. Other senior candidates were Bonnie Lewis, Angie Hayes, D'Andra Griffith, Brice Derr, Troy Brady and Sean Weiss.

- Jim Luce was endorsed by the Holt County Republican Committee to fill out the unexpired term of County Clerk Richard Buntz, who died September 11.

- Dispatching problems apparently had been resolved but Atchison-Holt Ambulance District Board members said there was plenty of other work to be done.

10 Years Ago - 2005

- The Mound City Public Library Board met with Mayor David Duncan and architect Ron Houston to review design drawings for a renovation of the first floor of city hall to house the library. Library Board President Glen Brown said that most library board members were pleased with the first-floor plans that would put the library in space previously used by the disbanded city fire department. Brown said the location would increase library space by about 60 percent.

- Seniors Jared Yocum and Jamie Webster were named king and queen for Mound City's homecoming. The Panthers beat King City.

- Monroe Produce opened in Craig earlier in the month offering fresh produce, Amish jams and jellies, eggs, milk and other items.

- Some of the tombstones at the Maitland Cemetery were starting to "suffer from old age," said Bob Terry, head of an Iowa company hired to fix them. He and his crew worked repairing 50 stones with problems such as tilting, loose tops, broken decorative pieces - or sinking.

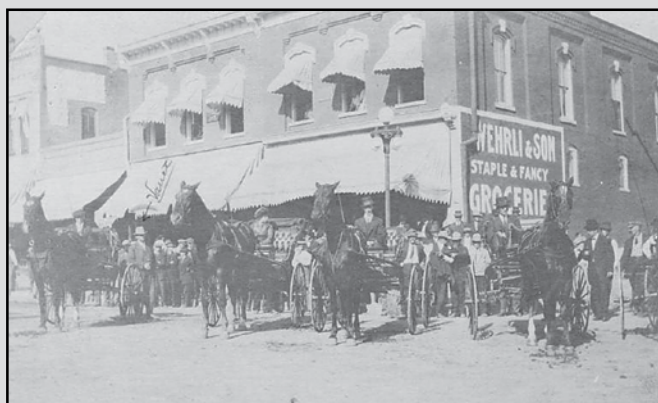

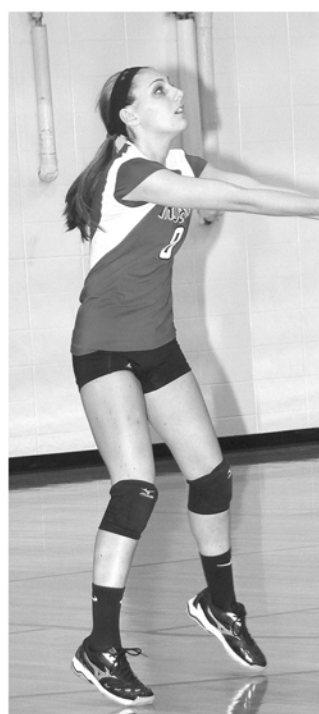

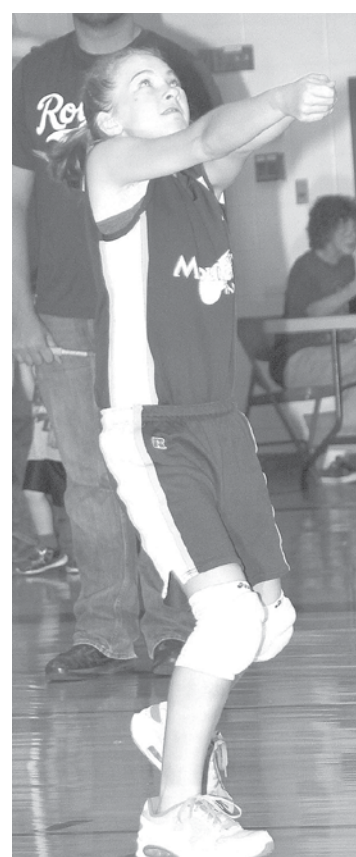
